Change History

June 14, 1941, created by H. G. Mauk, Chairman Constitution and By Laws Committee.

August 27, 2001: Change to Article 1 Section 2 to allow for a woman president. Passed by attendees of the August 27th, 2001 reunion.

Constitution

Article I.

<u>Section 1.</u> The name of this organization shall be MAUK FAMILY REUNION

Section 2. The members shall be the living descendants of JACOB MAUK, (1792-1866) and his wife, Susannah.

Article II.

<u>Section 1.</u> The purpose of this organization shall be to honor the memory of our illustrious ancestor, JACOB MAUK (1792-1866) and his wife, Susannah.

Section 2, Amended (8/28/2005) "The members will meet in annual reunion on the fourth Sunday in August.

<u>Section 3</u>, Amended (8/28/2005) "The reunion shall be held in the Punxsutawney, Pa. area at a site to be decided by a two-thirds vote of members attending the previous year's reunion."

<u>Section 4</u>, In the event this church shall be destroyed or removed, the reunion shall be held on the same location, which is the farm on which JACOB MAUK established his family in this part of the country.

Bylaws

Article I.

Section 1.

Amended (8/28/2005) "A Historian shall also be named by the governing body.." The section will then read: The officers shall consist of President, Vice-President, Secretary and Treasurer, annually elected. A Historian also shall be named by the governing body."

Section 2,

The President shall be a man or woman with the last name or the maiden name of Mauk and direct descendants of Jacob and Susannah Mauk.

Section 3,

If or when there is no man or woman with the last name or the maiden name of Mauk, any member of the organization shall be eligible for the office of President.

Article II.

Section 1.

The President shall be responsible for the success of the organization. The President shall preside at all meeting and may appoint chairpersons as needed for reunion committees such as Setups, Entertainment (for both adults and children), preceding Saturday Events, Door Prizes, Publicity, etc."

Section 2,

The Vice President shall assist the President and preside during the President's absence.

Section 3,

Amended (8/28/2005) The Secretary shall keep accurate minutes of all proceedings and assist with all-member reunion communications.

Section 4,

The Treasurer shall keep accurate accounts of all money in the treasury and pay no bills or accounts except as authorized by the governing body of the organization.

Section 5,

(New 08/28/2005) "The Historian shall keep records of births, deaths and marriages, as announced at the meetings or received from other verifiable sources, and shall oversee collection and maintenance of the organization's database."

To Add a New Clause Providing the Appointment of CommitteeChairpersons.

Article III.

Section 1,

The governing body shall be the organization when assembled in the annual meeting.

Section 2,

When not assembled, the governing body shall be the officers.

Section 3,

There shall be no routine procedure in holding meetings. The officers will proceed according to their own judgments.

Article IV.

Section 1,

Any action tending to give further honor to the memory of Jacob Mauk shall be within the meaning of this Constitution and Bylaws.

Article V,

Section 1,

Change in the Constitution or Bylaws can only be made by a two-thirds vote of any regular meeting or reunion.
